We call on you to bring the Fox Hill rezoning issue to a close. We citizens do not have time to study a 213-page comprehensive plan, a 222-page zoning ordinance, FHRE's 71 lines of proposed changes, and stacks of legal documents. As our democratically elected representatives, it's your job to render a verdict.

**We encourage you to vote NO to spot zoning Fox Hill for the following reasons:**

- This is an issue appropriately decided by you, our elected officials, who have citizen letters, meeting transcripts, expert advice, and land-use knowledge. If you vote your conscience and reject the proposal, the voters can always bring it to a town vote via petition, giving them the final say.

- More spot-zoning applications will be inspired by this proposal, threatening other Camden neighborhoods.
- The residents of Bay View deserve a final decision from you regarding the immediate future of their neighborhood, quality of life, and property values.
